Subject: Implementation of Certificate Tracking System

Dear Sir/ Madam,

I am pleased to announce the official launching of the GSO Certificate Tracking System. This system offers pertinent information to the relevant authorities responsible for Border Control and Market Surveillance in GSO member states.

The Certificate Tracking System is available through the same account for all notified bodies in the GSO Notification System (www.gso.org.sa/nb), the system's procedure is explained in the guidance document, and entails the affixing of the number of notified body and the QR-Code generated by the system under the G marking as follows:

- 1- For certificates issued before 1st July 2016, the notified body shall register all certificate in the system and reissue those certificates and shall print the G-Marking along with the number of notified body and the QR-code in the certificate as mandatory requirement, and on the product as voluntary,
- 2- All certificates issued starting from 1st July 2016, notified bodies shall register the certificates in the Certificate Tracking System, and shall print the G-Marking along with the number of notified body and the QR-code in the certificate as a mandatory requirement, and voluntarily on the product.
- 3- All products that are subject to conformity assessment involving intervention of notified bodies, shall bear the G-Marking with the number of notified body and QR-Code, starting from 1st January 2017 as mandatory requirement.
- 4- The payment of fees for registration of certificates is mandatory starting from the 1st October 2016. The fees are (500 SR/product/year), see the attached fee schedules.

Please note that each notified body can add one or more authorized contacts to use the system, an official request required for this purpose.
