Impact, Overview, Fees and Action Required

Impact Statement: A review of all Listing Reports is necessary to determine which products comply with new/revised requirements and which products will require re-evaluation. **NOTE:** Effective immediately, this revised standard will be exclusively used for evaluation of new products unless the Applicant requests in writing that current requirements be used along with their understanding that their listings will be withdrawn on Effective Date of **October 21, 2015** unless the product is found to comply with new/revised requirements.

Overview of Changes: Revised requirements to address EMC and special marking for massagers with exposed moving parts. Specific details of new/revised requirements are found in table below.

- April 21, 2015 = 6 Month Quote Cut-off Quotes returned for necessary re-evaluations
- September 19, 2015 = 30 Day Warning Client advised of all non-compliant Reports to be Suspended
- October 21, 2015 = Effective Date ATM Suspended for all non-compliant Reports
