Social responsibility

In a global economy, social responsibility has become one of the top priorities for trade as decreasing tolerance with regard to poor working conditions in production facilities represent a huge challenge for retailing companies as well as for suppliers.

Retailers and suppliers must now balance the needs of manufacturing ethically, high quality products at low prices.

BSCI monitoring system

The BSCI monitoring system is the European approach to tackle this challenge by improving social performance in supplier countries through a uniform social standards monitoring solution for retail, industry and importers.

The BSCI is based on the labour standards of the International Labour Organization (ILO) and other important international regulations like the UN Charta for Human Rights, as well as on national regulations. The Initiative aims at continuously improving the social performance of suppliers, leading to Best Practice like SA8000 certification or equivalents and thus sustainably enhancing working conditions in factories worldwide.
