GSO would like to clarify the action shall be taken for Cord extension sets by GSO Notified body to meet the new timeline:

1- Cord extension sets:

As the deadline 15th July 2020 for the conformity assessment procedures for **cord extension sets** the Notified body Shall follow these actions:

A. Information on existing certificates:

Notified Bodies shall provide through mail or on the forum (by choosing the right recipients):

- a. A tabulated list with the affected certificates (Suspended due to lack of cooperation from EO, suspended due to non-compliance with the new standard, Removed KSA from targeted countries, or Updated with the GSO standard)
- b. Certificates to be updated (under testing, not yet finalized by the Notified Body, or pending on the GSO system to take necessary action).

B. Information on the new certificates:

- c. Notified Bodies shall provide the updated notification scope, including GSO2117 to avoid rejection of any certificate issued without the capacity of the same.
- d. Notified Bodies shall not include Saudi Arabia as a targeted country in their certificates if they do not have the related accreditations scopes, or if the product is not complying with the GSO 2117 and related standards requested for the national deviations.

C. Cooperation and NBs duties:

- e. Notified Bodies are invited to provide their comments on utilising the GSO 2117 standard and the difficulties encountered in this process.
- f. Suggestions of the NBs to develop the process for more integration of procedures.

D. Extending the notification scope:

Interested NBs are invited to submit their applications for extension through the notification platform, and to follow the instructions in GSO announcement No (138) dated 17th July 2020.
