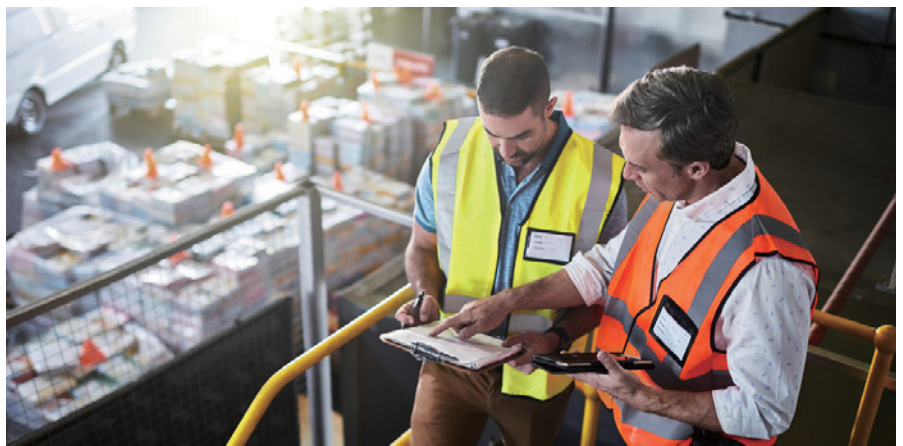


ISO 45001 认证

职业健康安全管理体系认证

ISO 45001将取代OHSAS 18001标准，并具备相关ISO标准的特征例如ISO 9001:2015和ISO 14001:2015，包括：采用了ISO管理体系统一的高级结构，利于组织多个管理体系的整合；危险源辨识和风险评估，员工参与等。通过落实本标准规定的要求，组织可以更积极主动地保护员工及组织自身。

雇员的工伤和死亡人数达到了惊人的高度。根据ISO 45001简报：据国际劳工组织(ILO)估测，2013年度因工死亡人数达到234万，其中绝大多数(200万)为职业健康原因，而非伤害有关。据职业安全和健康研究所(IOSH)预估，每年因工致​​癌死亡人数达660,000人。这些数字

表明，组织需要更加重视保护员工，并通过采取切实有效的控制措施确保他们的健康和​​安全。

ISO 45001旨在解决这些上述问题，帮助企业提高他们的OHS绩效。标准修订对组织的直接益处包括：

- 减少和降低员工消极怠工和离职率
- 可降低保险费用及成本
- 减少工伤事故带来的费用及成本
- 最大限度的减少对正常业务运行的不利影响和干扰

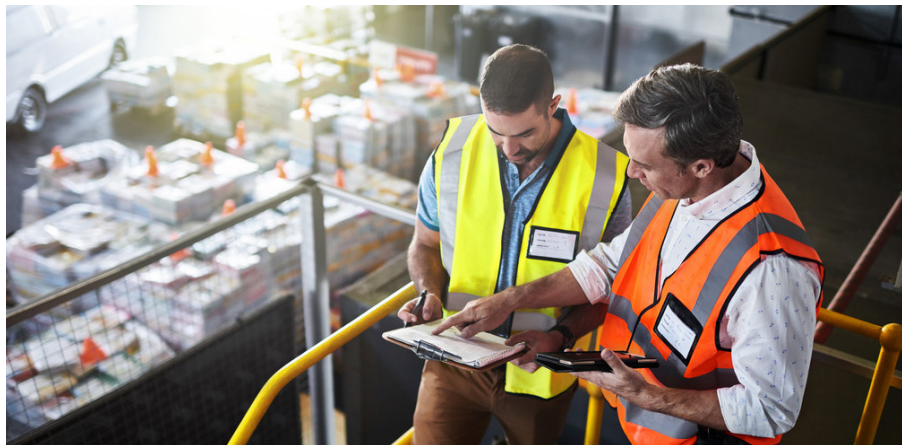

ISO 45001 CERTIFICATION

OCCUPATIONAL HEALTH AND SAFETY MANAGEMENT SYSTEMS CERTIFICATION

Providing a workplace that is as safe as it can be is not just important to the success of an organisation - it is essential.



Ensuring the continued health and safety of personnel in the workplace benefits not only the employees themselves, but also the organization as a whole. In light of an increasing number of fatalities and injuries incurred in the workplace or as a result of conditions in the workplace, ISO 45001 has been created to help organizations comply with more comprehensive regulations that govern occupational health and safety (OHSAS).

ISO 45001 will replace the OHSAS 18001 standard, and it will offer many of the features of related ISO standard like ISO 9001:2015 and ISO 14001:2015. These features include Annex SL – a High Level Structure that integrates with multiple management systems within the organisation, hazard identification and assessment of risks, and employee input. By acting in compliance with requirements set forth by this standard, organisations can become more proactive in protecting their employees and themselves.

Your Challenges, Our Solutions

The number of work-related injuries and fatalities for employees has reached staggering heights. According to the ISO 45001 Briefing Note, "There were, according to an estimate by the International Labour Organization (ILO), 2.34 million deaths in 2013 as a result of work activities. The greatest majority (2

million) are associated with health issues, as opposed to injuries. The Institute of Occupational Safety and Health, IOSH, estimates there are 660,000 deaths a year as a result of cancers arising from work activities." These numbers indicate a need for organisations to place more emphasis on protecting their employees by implementing processes to keep them healthy and safe in the workplace.

ISO 45001 aims to address these issues by helping organisations improve their OHSAS performance. Direct benefits of the revised standard for organisations include:

- Minimised absenteeism and turnover rates for employees
- Minimised insurance-related costs
- Minimised incident-related costs
- Minimised disturbances for operations
