ISO/IEC 27701考虑了控制或处理个人识别信息(PII)所需的隐私保护,并且确保您的流程和系统的设计,使得PII的收集和处理(包括使用、披露、保留、传输和处置)被必要的目的所限制。

The ISO/IEC 27701 take into account the privacy protections required for controlling or processing personally identifiable information (PII), and ensures that your

processes and systems are designed such that the collection and processing of PII (including use, disclosure, retention, transmission and disposal) are limited to what is necessary for the purpose.

Benefits of ISO/IEC 27701 to your organization:

- Reduces your risk to breach the privacy rights of individuals
- Demonstrates trust in managing personal information
- Demonstrates that you take data privacy seriously
- Determines roles and responsibilities
- Provides transparency to clients
- Supports compliance to privacy regulations

ISO/IEC 27701 does not expect organisations to adopt each and every control in all situations. Instead, it requires organisations to understand the particular context in which they process PII and adjust the particular set of controls and related implementation of those controls in a way that is appropriate to their processing activities.
