

1、China - Revised **Description and Definition** Table for Catalogue of **Compulsory Product** Certification. (Jan.5, 2015)

中国-修订了强制性产品认证目 录的描述和定义。 (2015年1月5日)

The Certification and Accreditation Administration of the People's Republic of China (CNCA) has recently published the "Description and Definition Table for the Catalogue of Compulsory Product Certification (Revised in 2014)"

中国国家认证认可监督管理委员会(国家认监委)与最近发布了"强制性产品认证目录的描述和定义 (2014年修订)"。

Content 内容

The Certification and Accreditation Administration of the People's Republic of China (CNCA) has recently published the "Description and Definition Table for the Catalogue of Compulsory Product Certification (Revised in 2014)" under CNCA Notice No. 45 of 2014. Scopes of products subject to Compulsory Product Certification are defined and described with examples in this table.

There are some changes from the previous version (2012) of this document. For example, a new category "Children articles" is created to replace the former category "Toys" to include the new product type "Restraining devices for child occupants of power-driven vehicles" which was announced last year and all (6) product types under the former category "Toys". However, scopes of 6 product types under the former category "Toys" remain unchanged. The new category "Children articles" now includes the following product types:

- 1. Children's vehicles:
- a. Bicycles for young children
- b. Children tricycles
- c. Wheeled child conveyances
- d. Baby walking frames
- e. Toy bicycles
- f. Electric children's vehicles
- g. Other toy vehicles
- 2. Electric toys
- 3. Plastic toys
- 4. Metal toys 5. Projectile toys
- 6. Doll toys
- 7. Restraining devices for child occupants of power-driven vehicles

中国国家认证认可监督管理委员会(国家认监委)与最近发布了"强制性产品认证目录的描述和定义 (2014年修订)",此次发布的目录收录在国家认监委的2014年第45号公告。此次发布的目录与2012年发 布的文件有了一些变化。例如,用一个新的类别"儿童用品"来取代之前的"玩具"。之前发布的6类玩 具产品没有变化,包括新的产品类型"机动车对儿童乘员的约束装置(儿童约束系统)∑"。新类别的"儿 童用品"现在包括以下产品类型:

2. Ecuador - Approved New Technical Regulation on Labelling of Party Articles (Jan.5, 2015)

厄瓜多尔核准关于聚会用品标签的核准技术规范。 (2015年1月5日)

Content 内容

The Ministry of Industry and Productivity of Ecuador (MIPRO) published Resolution No. 14 467 approving the new Mandatory Technical Regulation "RTE INEN 135 Labelling of Party Articles" which shall enter into force on 10 February 2015 to replace the previous emergent technical regulation as amended. Except the below highlights of changes on the requirements of labelling and evaluation of conformity, other requirements remain the same as those in the previous emergent technical regulation as amended by Amendment 1. Labelling Requirements

The information of labelling required can be placed on the product besides the label, container or packaging. On the other hand, the following information is no longer required:

- Full address of the manufacturer
- Warning of hazard that may arise from the nature of the product and its use when they are predictable.

4、 USA - CPSC Proposes Revised Prohibition of Children's Toys and Child Care Articles Containing Phthalates (16 CFR 1307) (Jan.8, 2015)

美国-美国消费品安全委员会 提议修订禁止儿童玩具和儿童 护理用品中使用邻苯二甲酸盐 (16 CFR 1307)。 (2015年1月8日) U.S. Consumer Product Safety Commission (CPSC) proposes a rule of "Prohibition of Children's Toys and Child Care Articles Containing Specified Phthalates" under section 108(b) of the Consumer Product Safety Improvement Act (CPSIA) for public comments in order to replace the current CPSIA's prohibitions on phthalates.

Content 内容

Here are highlights of the proposed rule:

- Continue the current permanent prohibitions on DEHP, DBP, and BBP 继续永久禁止DEHP, DBP和BBP的使用
- Not to continue the current interim prohibitions on DNOP and DIDP 取消对DNOP和DIDP的临时禁用
- Make the current interim prohibitions on DINP permanent and change the scope of regulation of DINP from the current interim scope of "children's toys that can placed into a child's mouth" (and child care articles) to include all children's toys
- 将临时禁用DINP更改为永久禁用DINP,且产品范围从可放入口中的儿童玩具和儿童护理产品扩大 到所有儿童玩具和儿童护理产品
- Prohibit children's toys and children care articles containing 4 phthalates that are not currently subject to restrictions under the CPSIA: DIBP, DPENP, DHEXP, and DCHP

Keep the same definitions of "children's toy" and "child care article" Be effective on 180 days after publication of the final rule in the Federal Register Here are the proposed prohibitions:

3、China - Postponed the Implementation of GB 5296.1 Instructions for Use of Products. (Jan.6, 2015)

5. Taiwan - Draft Amendment to Labelling Criteria for Stationery Goods (Jan.13, 2015)

台湾-起草对文具产品标签准则

的修订案。(2015年1月13日)

The Ministry of Economic Affairs (MOEA) of Taiwan has proposed to amend Article 4 of Labelling Criteria for Stationery Goods once again under the Notice No.10302438270.

台湾MOEA已经提议在No.10302438270.公告下修改文具产品标签准则中的条款4.

Content 内容

- 1. The labelling items shall be labelled distinctly with fixed stickers, print or tags on the product itself or the smallest unit of packaging. However, general stationery good with surface area less than 40 cm2, writing instrument with diameter less than 1.6 cm and stationery good sold singly in bulk can be labelled in other ways which are conspicuous enough to bring awareness to consumers.
- 2. Lengths and widths of the Chinese typefaces or numbers used for labelling shall be more than 0.15 cm respectively.
- 3. Lengths and widths of the typefaces of the words "警告" (means: Warning) and "注意" (means: Notice) shall be more than 0.3 cm respectively.
- 标签必须以明显的方式加贴在产品上,包括在产品本身上加贴粘 附的的贴纸,印刷或加吊牌以及加贴在包装上。但是,通常表 面积小于40平方厘米的文具,直径小于1.6厘米的书写工具和 大批量但逐个销售的文具可以用其它足够明显的方式给消费者提 供警示。
- 2. 标签上中文或数字的字体长宽都应该超过0.15厘米。
- 3. "警告"和"注意"的字体的长宽都应该超过0.3厘米。



The US State of Maine proposes to designate formaldehyde as a priority chemical under the Maine's Toxic Chemicals in Children's Products Law. It requires manufacturers or distributors to report for certain children's products containing intentionally added formaldehyde. No later than 180 days after the effective date of this rule, or within 30 days of the sale if the product starts to be sold after the 180-day reporting period ends, these manufacturers shall report to the Maine Department of Environmental Protection the following information:

7、 Brazil - Draft Amendments on Conformity Assessment Requirements for Party Articles (Jan.21, 2015)

巴西-关于聚会用品符合性评估 的修正案草案。 (2015年1月21日) The National Institute of Metrology, Standardization and Industrial Quality (INMETRO) of Brazil has published Portaria No. 565/2014 to propose amendments to the Conformity Assessment Requirements for party articles. 巴西国家度量,标准化及工业质量研究所(INMETRO)已通过法案 No. 565/2014以建议关于聚会用品符合性评估的修正案。

Content 内容

Follow Up 5 Date: January 21st, 2015

The National Institute of Metrology, Standardization and Industrial Quality (INMETRO) of Brazil has published Portaria No. 565/2014 to propose amendments to the Conformity Assessment Requirements for party articles. The major proposed changes are highlighted as follows:

INMETRO No. 545/2012

Article 3: The effective dates are respectively postponed to May 1, 2016 from Oct 29, 2014 (manufactured & imported), and to May 1, 2016 from Oct 29, 2015 (sold in the domestic market by manufacturers and importers).

Article 4: The effective date is postponed to May 1, 2018 from Oct 29, 2016 (sold in the domestic market).

9. Hong Kong - Proposes Adopting Up-to-Date Safety Standards for Toys and Children

The Commerce and Economic Development Bureau (CEDB) of Hong Kong has approved the proposal on adopting the up-to-date safety standards for toys and children's products. The new requirements shall become effective on 1 October 2015.

6、Maine/USA - Proposed Rule of Designating Formaldehyde as a Priority Chemical and Regulation of Formaldehyde in Children's Products (Chapter 885) (Jan.16, 2015)

10, Maine/USA - Revised **Proposed Rule on Designating** 4 Phthalates as Priority Chemicals (Chapter 888) (Jan.23, 2015)

美国缅因州-提出议案将四类邻 苯类增塑剂优先列入(川童产品 法规中的)化学品管控(第888章)。 (2015年1月23日)

Content 内容

The US State of Maine has revised the originally proposed draft rule on designating four phthalates (DEHP, DBP, BBP and DEP) as priority chemicals under the Toxic Chemicals in Children's Products Law. It requires manufacturers or distributors to report for certain children's products containing one or more of these regulated phthalates. Regardless of sizes of the manufacturers, the deadlines for reporting are changed to 180 days after the effective date of this rule, or within 30 days of the sale if the product starts to be sold after the 180-day reporting period ends. These manufacturers shall report to the Maine Department of Environmental Protection the following information:

- f) Any other information the manufacturer deems relevant to the reporting of the regulated phthalates, such information may include an assessment of alternatives to regulated phthalates performed by the manufacturer and the reason regulated phthalates are used.

11、 Albany County/New York State/USA - Approved Ban on Seven Chemicals in Children's Products (Jan.26, 2015)

The Albany County Executive has signed "The Toxic Free Toys Act" to approve to ban the sale of children's products or children's apparel containing benzene, lead, mercury, antimony, arsenic, cadmium, and cobalt within the county. This law shall take effect 1 year after its filing in the Office of the New York State Secretary of State

The Albany County Executive has signed Local Law No. "J" for 2014, known as "The Toxic Free Toys Act", to approve to ban the sale of children's products or children's apparel containing benzene, lead, mercury, antimony, arsenic, cadmium, and cobalt within the county. This law shall take effect 1 year after its filing in the Office of the New York State Secretary of State.

12 USA - CPSC Initiates Rulemaking Proceeding for **Corded Window Coverings** (Jan.26,2015)

美国-美国消费品安全委员会 近日发布了一则预告, 将发起 一项针对窗卷帘的立法。 (2015年1月26日)

13、 New York State/USA -**Proposes Prohibition of** Children's Foam Mats **Containing Formamide**

纽约州/美国-提出了禁用儿童 泡沫垫中甲酰胺的使用 (2015年1月28日)

The U.S. Consumer Product Safety Commission (CPSC) has issued an advance notice of proposed rulemaking (ANPR) to initiate a rulemaking proceeding for corded window coverings. Comments concerning the risk of injury associated with these products, the regulatory alternatives, the costs to achieve each regulatory alternative, the effect of each alternative on the safety, cost, utility, and availability of window coverings, and other possible ways to address the risk of strangulation posed to young children by window covering cords are invited. Interested persons are also invited to submit an existing standard or a statement of intent to modify or develop a voluntary standard to address the described risk of injury.

The State of New York has 2 bills (A00106 and S00583) in the same title and content introduced to propose the prohibition of the manufacture, distribution and sale of children's foam mats containing formamide 美国纽约州提出了提案A00106和提案S00583(两提案的标题与内容都完全相同),禁止生产、分销和 销售含甲酰胺的儿童泡沫垫。

Content 内容

According to the bills, from 1 December 2017, no person, firm, partnership, association, limited liability company or corporation shall sell or offer for sale in the State of New York any foam mat product containing formamide. However, it shall not apply to the sale or distribution of foam mat products resold or offered for resale, or distributed by consumers for consumer use.

根据提案的相关要求,自2017年12月1日起,任何人或企业都不得在纽约州销售含甲酰胺的泡沫垫。 但是,二手泡沫垫的销售或分销,或是消费者之间二手泡沫垫的转让将不受此要求的限制。

14、New York State/USA - Proposes to Require Warning Label for Holiday Decorations Containing Lead(Jan.29,2015) 纽约州/美国-提出了节日装饰品

(2015年1月29日)

Content 内容

The State of New York has a bill (S01712) introduced to propose to require warning labels for holiday decorations containing lead. If approved as proposed, the proposed act shall take effect on the 30th day after it becomes a law. 纽约州提出了提案S01712,要求含铅的节日装饰品添加警告标签。如果获得通过,该提案将于最终通过后的第30天生效。

According to the bill, a warning label containing "WARNING: CONTAINS LEAD. MAY BE HARMFUL. MAY GENERATE DUST CONTAINING LEAD." shall be printed on or attached to each holiday decoration sold or delivered by a manufacturer or distributor within the State of New York that 根据该提案的相关要求,所有在纽约州生产或销售的节日装饰品都需印刷或附带相关的警告标签 "WARNING: CONTAINS LEAD. MAY BE HARMFUL. MAY GENERATE DUST CONTAINING LEAD.",产品包括:

- (a) has paint or other similar surface-coating material thereon; or 有油漆或其他类似的表面涂层材料,或
- (b) is made of any plastic material 是由塑料制成的

·"Holiday decorations" shall include, but not be limited to, artificial Christmas trees, plants, flowers or wreaths, holiday lights, stockings, candles, figurines and bells.

15. New York State/USA – Proposes Prohibition of Soft Vinyl Lunch Boxes and Infant and Children's Vinyl Bibs Containing Lead.(Jan.29,2015)

纽约州/美国-提出了软PVC午餐 袋及儿童乙烯基口水兜中含有 铅的禁令(2015年1月29日)

Content 内容

The State of New York has a bill (A01756) introduced to propose an act in relation to lead in candy, soft vinyl lunch boxes, and infant and children's vinyl bibs. If approved as proposed, it shall take effect immediately. Here are highlights of the proposed prohibition for soft vinyl lunch boxes, and infant and children's vinyl bibs containing lead:

According to the bill, no person or entity shall manufacture, distribute, sell or offer for sale in the State of New York any soft vinyl lunch box, or infant or children's bib which contains more than 600 ppm of lead.




