1、EU – Withdraws Certain Harmonised Standards under General Product Safety Directive (GPSD) (2015.8.3)

欧盟-撤回部分通用产品安全指令下的协调标准 (2015年8月3日)

The European Commission has published the Commission Implementing Decision (EU) 2015/1320 to announce certain standards to be withdrawn from the general safety requirements of Directive 2001/95/EC. According to the decision, the following EU standards will no longer be harmonised and shall be withdrawn from the Official Journal of the European Union on 20 August 2015.

欧盟委员会发布了委员会执行决议2015/1320，撤销通用产品安全指令2001/95/EC下的部分协调标准。根据决议，下面欧洲标准不再被协调并于2015年8月20日被欧盟官方杂志撤销：

2、Maine/USA – Approved Final Rule on Designating Formaldehyde as a Priority Chemical in Children’s Products (Chapter 885) (2015.8.5)

美国缅因州 – 批准在儿童产品中规定甲醛为优先化学品的最终决议（第885章节） (2015年8月5日)

The US State of Maine has published the final rule on designating formaldehyde as a priority chemical under the Toxic Chemicals in Children’s Products Law. The rule is enforced with immediate effect.

美国缅因州公布了批准在儿童产品有害化学品法规中规定甲醛为优先化学品的最终决议。该决议立即执行。

The approved rule adopts the proposed details, and also emphasizes the children’s products to be reported shall be intended for use by children under the age of 12. According to the news posted on the Maine Department of Environmental Protection’s website, the reporting deadline of this new rule is 18 December 2015 which is same as that for four phthalates (DEHP, DBP, BBP and DEP, designated in Chapter 888).

批准的决议与当初的提案相同，也强调了所限范围是12岁以下儿童使用的儿童产品。根据新闻发布的内容在缅因州环保部门的网站上,这个新决议报告的最后期限是2015年12月18日，与第888章中指定的另外四个邻苯二甲酸酯（DEHP, DBP, BBP and DEP）公布的时间一样。

3、Egypt – Approves to Mandate Standard for Office Work Chairs (2015.8.5)

埃及通过关于办公椅标准的授权法案 (2015年8月5日)

The Ministry of Trade and Industry of Egypt has issued Decree No. 537/2015 to mandate some Egyptian standards including ES:495-2 “Office furniture Part 2: Office Work Chair - Safety Requirements”. The Decree has become effective and ES:495-2 shall be implemented on or before 22 January 2016. According to ES:495-2/2005 (the current version), it is technically identical to BS EN 1335-2:2000. Here are highlights of this Egyptian standard:

埃及贸易和工业部发布No. 537/2015法令授权ES:295-2办公家具第二部分：办公椅的安全要求标准并在2016年1月22日前实施生效。根据现行的ES:495版本，标准与BS EN 1335-2：2000内容一致。

4、MERCOSUR - Bolivia becomes a member of MERCOSUR (2015.8.6)

MERCOSUR(南方共同市场简称南共市，是南美地区最大的经济一体化组织) – 玻利维亚加入南共市 (2015年8月6日)

The Plurinational State of Bolivia signed on 17 July 2015 the Protocol of Accession to the Southern Common Market (MERCOSUR). Bolivia will gradually adopt the regulatory legacy of MERCOSUR, the latest four (4) years from now. The schedule for adoption of standards will be determined by a Working Group composed of representatives of the countries, in up to 180 days from the date of their first meeting.

多民族玻利维亚国(简称玻利维亚)于2015年7月17日签署加入南方共同市场（Mercosur）协议。从现在开始4年时间内，玻利维亚将逐步采用南方共同市场监管的规则。通过一个由各国代表组成的工作组来确定具体的时间表，将在180天内召开第一次会议。

The country has also 4 years to adopt the MERCOSUR Common Nomenclature (NCM), the Common External Tariff (CET) and MERCOSUR Origin Regime. MERCOSUR is formed by six members: Brazil, Argentina, Paraguay, Uruguay, Venezuela and Bolivia. Venezuela was included in 2012 and have up to 2016 to adopt the regulatory legacy of MERCOSUR.

国家需要4年采用南共市共同命名（NCM），共同对外关税（CET）和南共市的原产地制度。南方共同市场由六名成员组成：巴西，阿根廷，巴拉圭，乌拉圭，委内瑞拉和玻利维亚。委内瑞拉是包含在2012和2016采用南方共同市场监管遗产。

5、 EU – Compliance of New EU Standards for Child Care Articles and Children’s Clothing (2015.8.7)

欧盟-儿童护理产品和儿童服装需符合欧盟新标准 (2015年8月7日)

The European Union (EU) has published the Commission Implementing Decision 2015/1345/EU to announce that the following references of standards for children’s clothing, carry cots and stands, safety barriers and changing units for domestic use comply with the general safety requirements of Directive 2001/95/EC on general product safety. According to the decision, they will be harmonized and published in the Official Journal of the European Union.

1. EN 14682:2014 Safety of children's clothing - Cords and drawstrings on children's clothing – Specifications儿童服装安全-儿童服装上的绳子及抽拉绳-技术规范
2. EN 1466:2014 Child use and care articles - Carry cots and stands - Safety requirements and test methods 儿童使用和护理产品-拎篮及支架-安全规范及测试方法

5. EN 12221-2:2008+A1:2013 Child use and care articles - Changing units for domestic use - Part 2: Test methods 儿童使用和护理产品-家用尿布台-安全规范及测试方法

6、 Texas/USA - Approved to Eliminating the Law Label on Bedding Items (2015.8.13)

美国得克萨斯州 同意废除床垫用品的法律标签要求 (2015年8月13日)

On 17 June 2015, Texas passed a Senate Bill 202 and signed into a law by governor on eliminating licensing of bedding items. Law label will no longer be required for bedding items in Texas and this new law will become effective on September 1, 2015.

2015年6月17日，得克萨斯州通过了202号州参议院议案并由政府签署法律废除床垫用品的规定要求。在德州床垫用品将不再要求有法律标签，此新法律将于2015年9月1日生效。

7、 United Arab Emirates - Draft Control Scheme to Restrict the Use of Hazardous Materials in Electronic and Electrical Devices (2015.8.17)

阿拉伯联合酋长国 – 提出在电子电器设备中限制使用有害物质的草案 (2015年8月17日)

Technical Requirements / 技术要求

All products, including cables and spare parts for their repair, their reuse, updating of their functionalities or upgrading of their capacity, shall not exceed the following maximum concentration values by weight in homogeneous material for restricted hazardous substances:

所有产品,包括电缆和其他修复、再利用、有更新功能或升级能力的所用备件, 均质材料中有害物质的含量不得超过以下限制的最大浓度值：

- Lead铅 (0.1 %)
- Mercury汞 (0.1 %)
- Cadmium 镉(0.01 %)
- Hexavalent chromium六价铬 (0.1 %)
- Polybrominated biphenyls (PBB) 多溴联苯 (0.1 %)
- Polybrominated biphenyl ethers (PBDE) 多溴联苯醚(0.1 %)
- Bis(2-ethylhexyl) phthalate (DEHP) 邻苯二甲酸二乙基己酯 (0.1 %)
- Butyl benzyl phthalate (BBP) 邻苯二甲酸苄丁酯(0.1 %)
- Dibutyl phthalate (DBP) 邻苯二甲酸二丁酯(0.1 %)
- Diisobutyl phthalate (DIBP) 邻苯二甲酸二异丁酯(0.1 %)

8、 USA – CPSC Proposed Safety Standard for Infant Bath Tubs (16 CFR 1234) (2015.8.18)

USA – CPSC 婴儿浴盆的安全标准提案 16 CFR 1234 (2015年8月18日)

The U.S. Consumer Product Safety Commission (CPSC) has proposed a new draft safety standard (16 CFR 1234) for infant bath tubs. The draft standard is based on the voluntary ASTM standard for infant bath tubs (ASTM F2670-13), with modifications to test methods, warning statements and instructional literature.

新的草稿版婴儿浴盆安全规范16 CFR 1234已由美国消费品安全委员会提出议案，此标准基于浴盆标准ASTM F2670-13来编写。

9、 Japan – Proposes Enforcement Order and Ministerial Ordinance relating to “Act on Preventing Environmental Pollution of Mercury” (2015.8.21)

日本 - 提议关于“环境保护中的水银控制行动”的强制命令及部门条例 (2015年8月21日)

Ministry of Economy, Trade and Industry (METI) and Ministry of the Environment (MoE) have proposed an Enforcement Order and a Ministerial Ordinance relating to “Act on Preventing Environmental Pollution of Mercury”.

经济，贸易和工业部（METI）以及环境部（MoE）已经提议关于“环境保护中的水银控制行动”的强制命令及部门条例。

I. Enforcement Order of the Act

The Enforcement Order of the Act designates mercury-added products listed in Annex A of the Minamata Convention on Mercury as “Specified mercury-added products”, and sets corresponding mercury content limits lower than those in the Convention as well as phase-out dates earlier than those in the Convention. The list of products includes electrical and non-electrical products. No party is allowed to manufacture, import or export of Specified mercury-added products beyond the phase-out date.

II. Ministerial Ordinance of the Act

1) Mercury-added products for known use: Mercury-added products listed in Annex A of the Minamata Convention on Mercury

2) Mercury-added products for new use: Mercury-added products not covered by Mercury-added products for known use

The manufacture or distribution in commerce of Mercury-added products for new use is not allowed unless the use of such products demonstrates environmental or human health benefits. Further, the manufacturer or distributor shall carry out a self-assessment for the products.

I. 行动强制命令

行动强制命令指定了相关水俣公约的附录A清单中水银添加产品为“特别水银添加产品”，同时设定相应低于公约的水银限制，并且早于公约规定前实施。此清单包括电器及非电器产品。在实施日期前，任何单位不得生产，进口和出口特别水银添加产品。

II. 行动部门条例

1）已知用途水银添加产品：水俣公约的附录A清单中水银添加产品

2）新用途水银添加产品: 未被“已知用途水银添加产品”覆盖的含有水银添加的产品

对于新用途水银添加产品不得被用于商业生产和销售，除非证明此产品对于环境和人体健康无害。并且，生产商或销售商应提供产品的自我评估。

10、Canada – Amends Proposed Cribs, Cradles and Bassinets Regulations (2015.8.24)

加拿大-修订了提议中的童床、摇篮和摇篮车法规 (2015年8月7日)



11、Switzerland – Proposed Amendment on Toy Safety Ordinance (2015.8.25)

瑞士提议修订玩具安全条例 (2015年8月25日)

The Canada Gazette has published an erratum for the recently proposed “Cribs, Cradles and Bassinets Regulations” (CCBR) regarding the construction requirements of cribs, cradles, bassinets, sleep accessories and stands. Section 39 of the draft CCBR shall be revised as follows:

加拿大公报公布了最近提出的《童床、摇篮和摇篮车法规》(CCBR)有关童床、摇篮、摇篮车、睡眠附件或平台结构要求中的一个勘误。草案39部分应修订如下：

39. (1) Every crib, cradle, bassinet and sleep accessory must be constructed so that the angle of the mattress support does not exceed 10° 7° from the horizontal.
39. (1)每个童床、摇篮、摇篮车、睡眠附件的设计应能确保床垫的支撑面不能倾斜超过水平面10° 7°以上。
- (2) Every stand must be constructed so that the angle of the mattress support of a crib, cradle or bassinet that is placed on or fixed to it does not exceed 10° 7° from the horizontal.
- (2) 每个平台的设计应能确保其上或固定其上的童床、摇篮、摇篮车床垫的支撑面不能倾斜超过水平面10° 7°以上。

Switzerland has published a draft amendment to the Toy Safety Ordinance (SR 817.023.11). The amendment is proposed to be effective from 1 October 2015. Here are highlights of the amendment:

1. Additional exemption for toy components with nickel which are intended to conduct an electric current对玩具中用于导电的部分含镍部件豁免
- The presence of nickel is allowed in toys and toy components made of stainless steel (except nickel-plated parts that come directly into prolonged contact with the skin).不锈钢玩具部件中允许含镍（除直接长期接触皮肤的镀镍部件）
2. New migration limit of lead which is lower than the Toy Safety Directive 2009/48/EC 低于玩具安全指令2009/48/EC的可迁移铅的新限值

12、Switzerland – Proposed amendment on Ordinance on Materials and articles intended to come into contact with foodstuffs (2015.8.27)

瑞士-建议修改食品接触材料法令 (2015年8月27日)

The Federal Food Safety and Veterinary Office (FSVO) proposed an Ordinance on materials and articles intended to come into contact with foodstuffs. The draft Ordinance shall reduce the legal differences with the European Union. This Ordinance will enter into force one year after approval.

联邦食品安全及兽医办公室（FSVO）提议一项法案。该法案涉及食品接触材料。草案意在减少和欧盟法规的不同之处。法案一旦成立将会于批准后一年后实施。

- The main changes are added as below: 新增变化如下：
- 1. Introduction of the requirement to follow Good Manufacturing Practices (GMP) for the manufacturing steps

 - 2. Introduction of traceability, such as setting up of Quality Assurance and control systems

13、Switzerland – Proposed Amendment on Ordinance on Articles Contacting the Human Body (2015.8.27)

瑞士- 关于人体接触产品的修正提议 (2015年8月27日)

Switzerland has proposed a draft amendment on Ordinance on Articles Intended to Come into Contact with Human Body (SR 817.023.41). This involves modifying chemical requirements for certain consumer products and technical standards for determining the flame resistance of textile products. Here are highlights of the amendment:

1. Textile and leather products
- a. SN EN 13772:2011 is added to the list of technical standards for testing the flammability of textile and leather products:
 - SN EN 1101:1995 with corrigendum A1:2005
Textiles and textile products. Burning behaviour. Curtains and drapes. Detailed procedure to determine the ignitability of vertically oriented specimens (small flame)
 - SN EN 1102:1995
Textiles and textile products. Burning behaviour. Curtains and drapes. Detailed procedure to determine the flame spread of vertically oriented specimens
 - SN EN 1103:2005
Textiles. Fabrics for apparel. Detailed procedure to determine the burning behavior
 - SN EN 13772:2011
Textiles and textile products. Burning behaviour. Curtains and drapes. Measurement of flame spread of vertically oriented specimens with large ignition source

2. Jewellery and imitation jewellery
- a. External metal parts of jewellery and imitation jewellery articles shall not have cadmium content greater than 0.01% by weight of metal parts, such as:
 - hair accessories
 - bracelets
 - necklaces
 - rings
 - piercing jewellery
 - wrist watches
 - brooches
 - cufflinks
3. Articles with plastic or rubber components
- a. Any plastic or rubber components of articles shall not contain more than 1 mg/kg (0.0001% by weight of component) of any of the listed polycyclic aromatic hydrocarbons (PAHs). Examples of such articles are:
 - clothing
 - shoes
 - gloves
 - sportswear
 - watches
 - bracelets
 - masks
 - headbands
 - b. Any plastic or rubber components of childcare articles* shall not contain more than 0.5 mg/kg (0.00005% by weight of component) of any of the following listed PAHs.
 - c. The listed PAHs are:

4. Tattoo colours and permanent makeup colours

a. The colours shall not contain:

- prohibited substances listed in Annex 2 of the Ordinance on Cosmetics (OCos, SR 817.023.31)
- dyes listed in Annex 4 of OCos complying the restrictions and requirements in column (g)

b. Tattoo colours intended to be applied on skin shall only contain preservatives permitted in Annex 5 of OCos, complying with the specified maximum levels. Any mixture of preservatives in Annex 5 shall be excluded.

1. 纺织及皮革产品：

a . SN EN 13772:2011 被加入技术标准用于纺织及皮革产品的燃烧测试

•SN EN 1101:1995 (含勘误表 A1：2005)
纺织品及纺织产品。燃烧表现。窗帘及垂幔。具体流程用于判断垂直导向样品的燃点（小焰）

•SN EN 1102：1995
纺织品及纺织产品。燃烧表现。窗帘及垂幔。具体流程用于判断垂直导向样品的燃烧速度

•SN EN 1103:2005
纺织品。围裙纤维织物。具体流程用于判断燃烧表现。

•SN EN 13772:2011
纺织品及纺织产品。燃烧表现。窗帘及垂幔。在大点火源情况下测量垂直导向样品的火焰传播速度。

2. 珠宝及仿真珠宝

a.对于珠宝及仿真珠宝其外部金属部分的镉含量在重量上不能超过整体金属重量的 0.01%。 例如：

•头饰 •手镯 •项链 •戒指 •能穿刺珠宝 •腕表 •胸针 •袖口

3. 含有塑料及橡胶部件的产品

a. 任何含有塑料及橡胶部件的产品的已列出的多环芳烃(PAHs)含量不能多于 1mg/kg（产品重量的 0.0001%），产品例如：

•服装 •鞋类 •手套 •运动服 •手表 •手镯 •口罩 •头巾

b. 任何含有塑料及橡胶部件的儿童产品的已列出的多环芳烃(PAHs)含量不能多于 0.5mg/kg（产品重量的0.00005%）：

9、Brazil-Approved to Adopt the New Labelling, Other Requirements for Mattresses and Mats of Flexible Polyurethane Foam (2015.8.28)

巴西-批准了对床垫和有弹性聚氨酯泡沫垫子的新标签及要求。(2015年8月28日)

The sale prohibition shall become effective 1 year afThe National Institute of Metrology, Standardization and Industrial Quality (INMETRO) of Brazil has issued an Ordinance 349/2015 to clarify the current conformity assessment requirements for mattresses and mats made of flexible polyurethane foam established by Ordinance 79/2011 and set new labelling and other requirements for these products.
